EXTENSION OF THE TOURIST OR TRAVELER VISA REQUIREMENTS

- Form of the Extension of the Tourist or Traveler Visa.
- Valid and current passport in original with the latest admission seal to the Guatemalan territory or a Migratory Movement Certification must be presented.
- Either of the following documents must be presented:
 - a. Travel ticket.
 - b. International credit card.
 - c. Constancy of the Guatemalan Guarantor registration.
- Proof of payment.

OBSERVATIONS:

Present duly for admission without erasures or alterations.

1. **CURRENT PASSPORT:** The Guatemalan visa will only be issued in a current and valid Passport with a minimum validity of 6 months.
2. **FINE OF IRREGULAR PERMANENCY:** The extension application can only be done before the given time expires so that the fine of irregular permanency does not proceed or for it to be a cause of justified expulsion. When the given time expires, with the extension already stamped, the Guatemalan Migration Institute will be able to impose the sanction of the justified expulsion of the national territory and cancel the given visa, this without perjury of the application of the fine of irregular permanency.
3. **ENTRANCE SEAL:** The Passport or travel document will have to contain the entrance seal to the national territory or the other States that form part of the CA-4 (El Salvador, Honduras and Nicaragua). Counting the date of the seal, the permanency inside of the territory of the CA-4 will be determined.
4. **MIGRATORY MOVEMENT:** When the Passport does not count with an entrance seal, a migratory movement will be presented.
5. **COPY OF THE CREDIT CARD:** If an international credit card is presented, a simple copy of the card will be presented.
6. **GUATEMALAN GUARANTOR:** When the procedure is performed with a Guatemalan Guarantor, a notarial deed of sworn declaration of constitution of guarantor will have to be presented.
7. **SIMPLE COPY OF THE PASSPORT INFORMATION SHEET:** A simple copy will be presented containing the valid and current information of the Passport.
8. **MINORS:** When the request is submitted by a third party, documentary evidence of the authorization of both parents and whoever exercises legal representation.
