- Proof of payment

## Observations

- PAYMENT OF ANNUAL FEE FOR FOREIGNERS all foreigners requesting certificates and constancies must be solvent in the payment of the annual foreigner's fee and other obligations, if applicable, presenting the corresponding proof of payment.
- DATA UPDATE all applicants requesting certificates and constancies must have updated their ordinary immigration status record withing the year of the application, if applicable.
